



MJ Law Tactical / Range Safety Rules

_____ 1. Do not un-holster or load any handgun behind the designated firing line. Any long gun removed from a case, carried in hand or by sling must be clear of ammunition. All firearms will be loaded / unloaded on the order from the range officer in charge and at a designated forward line.

_____ 2. Eye / ear protection, a billed cap, and closed neck T-shirt are mandatory and must be worn at all times on the range when live fire is being conducted. Eye protection should be worn when cleaning firearms. **NO** shorts or sandals are permitted.

_____ 3. Do not move forward of the firing line until the line has been declared safe to do so by a Range Officer.

_____ 4. While on the firing line, do not turn around or step off the line while your handgun is in your hand until cleared and made safe.

_____ 5. Do not bend over or move forward to pick up magazines or other items from the ground / floor until the Range Officer has declared the firing line safe and you have holstered your pistol and / or cleared and made safe your long gun.

_____ 6. While on or off the firing line, handguns will be carried in a holster or pistol case. No handgun will be carried in the waistband or other unsecured fashion.

_____ 7. All officers on the range have the authority to call a "cease-fire" should they observe an unsafe act or condition which constitutes a safety hazard.

_____ 8. No person will be permitted on the range if they have consumed alcohol or if taking medication that could impair their ability to understand and follow instructions and handle a firearm safely.

_____ 9. In private, advise the lead instructor of any injury or physical condition that may prevent you from participating in any training exercise.



Fundamental Firearms Safety Rules:

- _____1. All firearms will be treated as loaded and capable of firing.
- _____2. Always point the muzzle in a safe direction, where no one will be injured should the firearm discharge. Do Not turn your muzzle sideways or behind into the shooter next to or behind you. Muzzle Direction is VITALLY IMPORTANT!
Both shooter error and mechanical failures can and have occurred.
- _____3. Keep your finger off the trigger until your weapon is on the target and you have made the decision to fire. Finger OFF trigger except when firing.
- _____4. Be sure of your target and take into consideration the backstop and what is beyond.

Consent to Training and Release of Liability

Consent. Participant has consented to taking part in the Training entirely on his/her own initiative and at this/her own risk, and recognizes and assumes the dangers associated with the Training. The Training, including, but not limited to demonstrations, drills, simulations and other activities, involves extreme physical exertion and exposure to hazardous conditions. Fitness to Participate. Participant represents that they are now in good health and in sufficient physical condition to participate in the Training and does not now suffer, and has not suffered in the past from any physical, mental, or emotional condition that could in any way impair their ability to safely participate in the Training.

Release. PARTICIPANT, FOR HIMSELF/HERSELF AND THEIR HEIRS, ESTATE, SUCCESSORS, ASSIGNS, AND THEIR RESPECTIVE, DIRECTORS, OFFICERS, MEMBERS, MANAGER S, EMPLOYEES, STAFF, VOLUNTEERS, AND AGENTS FROM ANY AND ALL LIABILITY FOR ANY INJURY OR DEATH ARISING OUT OF OR OTHERWISE RELATED TO PARTICIPANT'S PARTICIPATION IN THE TRAINING.

Rules of Training. Participant promises to use their best efforts to seek clarification and instruction from Michael Pichardo, regarding any rule, policy, safety procedure, condition, or any other aspect of the Training that Participant does not understand.

5. Publication Rights. Participant maintains responsibility for compliance with all applicable laws. No other obligations, liabilities or responsibilities apply or are implied. Participant may not assign its rights or obligations under this Agreement. Michael Pichardo failure to exercise any of its rights hereunder shall not constitute or be deemed a waiver or forfeiture of such rights. If any provision of this Agreement is deemed or found invalid or unenforceable, the parties contend that all other provisions shall remain unimpaired and in full force, and the parties or the court shall substitute for the invalid provision a valid

provision that most closely approximates the intent and economic effect of the invalid provision. This Agreement shall be construed under the laws of the State of Illinois, as if performed wholly within the state and without giving effect to the principles of conflicts of laws. Any action or proceeding seeking to enforce any provision of, or based on any right arising out of, this Agreement must be brought against any of the parties in the courts of the State of Illinois having subject matter jurisdiction. This Agreement constitutes the entire agreement between the parties and may be modified only by written agreement of the parties.
